Rules and Regulations

- The candidates willing to seek admission to the academy has to go through the following rules and regulations carefully.**
1. Fee once deposited is neither refundable nor transferable under any circumstances.
 2. The academy reserves the right of admission, termination and batch allotment.
 3. The genuine expectation of the Academy from the students is to maintain discipline throughout the course.
 4. The Academy reserves the right to cancel the admission, in case of indiscipline/misbehaviour.
 5. Every candidate is required to carry his/her identity card while entering to the Academy. No impersonation will be allowed in any case.
 6. The Academy shall make the best arrangements for coaching under certain limits. The candidates are not supposed to intervene the administrative affairs.
 7. The candidate should maintain punctuality during the coaching and he/she should appear in all the test assignments which would help monitoring their performance. No special lecture/assignments will be arranged for those who fail to attend the regular schedule.
 8. The Academy has a fixed coaching plan but, under unavoidable circumstances, it reserves the right of inter changing or alteration in the Plan.
 9. A student can procure one book at a time from the library. The book can be retained at the most for three days. Any loss or damage to the book will be charged compensated from the student's caution money.
 10. The student if leaves the institution within six days of admission (sixth day inclusive) than three fourth (3/4) of the total fees deposited shall be refunded.
 11. Cause 10 and 11 are applicable only and only for those who have deposited their total fees. The registrations fee will not be refunded in any case. Clause 10 and 11 are applicable for those who have deposited their full fees at one time.
 12. Clause 10 and 11 are not applicable for the students who have deposited their fees in installment. The student paying fees in installment has to pay Rs. 1,000/- (One thousand only) of the total fees as an interest amount.
